

Taking Bus Safety to a New Level!

objective is to transport our students from home and to school and back in the safest way we know how. School buses are the safest means of transportation we can provide for them... so the question is...are they safe? That is what parents and the public want to know. The key to being able to answer "YES!" to that question is a daily maintenance schedule.

Every transportation director will tell you stories about THE STATE INSPECTION. But the key to a successful state inspection which should occur in every day is a daily maintenance inspection. The implementation of a daily maintenance inspection which involves bus drivers, mechanics and the transportation director is the path to achieving well above a 90% on the annual state inspection and spot inspections. State inspections are both a challenge and a source of stress which require staying ahead of the game daily. The price of becoming inattentive or getting sloppy with bus maintenance isn't a low inspection score. The real price is endangering students lives!



The first and the most important part of the strategy will be to never let your guard down or just a good attitude check!!! You must at all times think of every bus, every student and every driver are the goals you must achieve daily for their safety. IT MUST BE THIS WAY!! And when you get this down...you will see it is a lot easier to achieve to receive those higher percentages!

Strategy 2

You must have some type of preventive maintenance schedule or a condition report on each school bus. Do this through the week. Keep good preventive maintenance records and good track of your repairs. Know where you stand on each bus on how it is performing. This will save you time and money for your district as well.



Establish a Inspection Team of drivers you trust that are somewhat mechanically incline or have a darn good eye to be very detailed to look for defective parts or failures. You must also pick a day to train them on what to look for and how you want it done. 4 drivers... each driver have a specific job duty on and around the bus. This will keep each driver focused on their job only!




Use an Inspection check off list! This way you have documented and have checked off the components on the bus good or bad and do a thorough inspection. I have added attachment to the MAPT website where you can print off these check off lists. Each sheet will define each drivers or persons job before pulling the bus in the barn for the actual inspection.

Using this strategy can get you a 100%. It's just how bad you want it! The key is the first 2 strategy points...it has to be a yearly goal and can't be done a month or two before inspection day! It is a team effort and you can do it for the students in your district.

We are all in this together!

I do want to say one more thing...we are all in this together! Big school, small school, logistically it is all the same! We serve one purpose...that is to get kids home safely to and from school. It is a national wide effort to get the job done right...and I know we all want that! God Bless!

What You Need to Know...

Missouri Department of Elementary and Secondary Education Update

THE FOLLOWING ARE CURRENT ITEMS THAT SCHOOL DISTRICT TRANSPORTATION DIRECTORS, ADMINISTRATORS, AND SCHOOL BUS CONTRACTORS NEED TO BE AWARE OF RELATING TO MISSOURI PUBLIC SCHOOL TRANSPORTATION

Real ID

The Missouri Department of Revenue's website information page has been updated regarding the REAL ID implementation which is scheduled for March 25, 2019. Noted below are the two primary links to get to the updated information.

2018-19 State Transportation Aid Calculation

This is the fourth live state transportation calculation made for the current year. The calculation is based on 2018-19 school year data submitted by the district on the state transportation aid documents included in Part IV of the Annual Secretary of the Board Report (Application for State Transportation Aid, School Bus and Facility Depreciation Schedules).

The percent of reduction to the calculated entitlement computed for the January 2019 calculation follows. This reduction percentage represents the amount the entitlement exceeded the appropriation and will fluctuate from month to month as revisions are made to individual school district data. The percent of reduction and the A and

B factors are also reflected on each district's Summary Transportation Report.

The percentage reduction and the A and B factors are as follows:

School Bus Purchases

Jan 2019Reduction Factor:66.609272%A Factor:3.525846B Factor:-1.354847

Missouri Statute 304.060, RSMo, requires school districts to comply with State Board of Education regulations that set school bus safety standards (this statute carries a "guilty of misconduct" violation for any school employee who does not comply with this requirement). School districts and their school bus contractors are required by State Board of Education Regulation 5 CSR 30-261.025 to operate only school buses that meet Missouri Minimum Standards for School Buses. In addition, school bus manufacturers are also charged in the Minimum Standards with certifying that their product meets the Minimum Standards for School Ruses

Please make sure that all school bus purchases, including used school

buses, specify that the school bus meets Missouri Minimum Standards for the year in which the bus was manufactured. Several states do not have the same specifications that Missouri does; such as the fire block seat upholstery, the second stop arm, and the lower side skirts.

Ridership List

The second ridership list for the current school year must be finalized on the second Wednesday of February (February 13, 2019.) This list should be a compilation of the students' names that regularly ride the bus from the beginning of the second semester to the February count day and should identify which students are eligible for state transportation aid (those living one mile or more from school) and those ineligible for state transportation aid (those living less than one mile from school.)

The ridership list should not be a listing of all students who are eligible or ineligible to ride the buses nor should it be a listing of only those students riding on the count day, but should be a listing of students regularly riding the buses. A student should ride the school bus a minimum of once a week to be considered a regular rider.

Let's Finish the Year on a High Note

"e have reached that time of the year when many of us start the year-end countdown. Everyone is getting tired and weary of the cold wet weather and looking forward to summer. It may be a struggle at times, but we can all take a deep breath, get our second wind, and finish the year out on a high note. We do it because as transportation professionals we know the yellow bus that connects the neighborhood to the school is a vital part of the educational pro-CESS

The school bus is an amazing piece of equipment. It's a fact that the yellow school bus transporting students to and from school is 70 times safer than any other mode of ground transportation. We are often asked is it just the way the bus is manufactured that makes it safe? While the safety features and strength of the structure are no doubt a huge part of the 70 times safety factor, I believe the entire transportation staff, the transportation professionals, who make student transportation work efficiently every day are the biggest denominator in the positive numbers. If it wasn't for the loyalty and dedication of student transportation professionals across the country, day in and day out, that care about the job they do and the students they transport the "70 times safer" we like to boast about would look terrifyingly different.

How much safer? Well about 70 times safer than traveling by car*—even if a parent is the one doing the driving. Once you factor in the cost, convenience and carbon footprint benefits of the school bus, it's hard to find a reason to send children to school any other way. So why no good press for the yellow bus and the professionals

that make student transporta-

tion what it is today? Maybe it's the sign of the times. We live in a time and culture that social media has created. The high standards the gatekeepers of the past once had, have been lowered to make room for news that is raw, unfiltered, uninformed and much of the time untrue. At one time in the past, verification and journalistic discipline was at the core of the information published. The general public could make informed decisions about many important topics based on the information they received. This is not so today.

Unfortunately we do receive negative media coverage when something happens. How do we respond to all the negative and sometimes false press? As student transportation professionals the first step is the job at hand. We work in a field that demands high standards, we can't just say it. We have to live it, we need to be above reproach. It must be seen in our daily operation. We must set the standard.

We have to obey all of the laws of the road, stop when the signs say stop, drive the speed limit, and treat the students behind us as if they are the most important



while transporting them. Many of the young people I have had the pleasure, and sometimes not so much pleasure of knowing, are now teachers, law enforcement officers, bankers, doctors and the list could go on and on. We know they are the adults who will be taking care of us in the future and I want them to remember me as the caring person who was patient and concerned for them, even when they chose to use bad judgement and be disrespectful or misbehave. 2019 National School Bus Safety Week Poster Contest

Theme: Red Lights Mean STOP!

WHO MAY ENTER:

Any student enrolled in a public, parochial or other private elementary or middle school (plus High school for Divisions 4 and 5 only) in the United States of America, Canada or an overseas US military installation may submit artwork to the National School Bus Safety Poster Contest.

POSTER SPECIFICATIONS:

Completed poster size must be 11" x 17" or 12" x 18". Posters may be illustrated on the vertical or horizontal axis.

Designs should be submitted on quality tag, poster illustration board or heavy paper. Construction paper may be used but winning entries must be mounted on quality tag poster. Lamination is not permitted and will disqualify the poster.

There is no limitation on the use and number of colors.

There is no limitation on the type of media -- such as print, crayon, felt pen, etc. -- used on the poster design; however, wood, plastic, glass or metal should not be part of the poster. Collage materials should not be used. Glued on pieces will disqualify the poster.

Lettering and Drawing: The poster design may incorporate freehand letters only. Stenciled, pre-printed, manufactured stick-on or press-on letters or tracings may not be used and will disqualify the poster. Lettering should be clearly legible, even if used as part of the poster design. Cut paper / stencils (freehand or pre-drawn stick-on stencils) are not permitted and will disqualify the poster.

Poster designs may not incorporate any copyrighted materials (i.e., comic and/or television characters), including stock artwork, meaning photographs or other images of common places, landmarks, nature, events or people; clip art, meaning anything from an existing collection of pictures or images that can be imported from or into the poster; and non-original raster graphics or vector graphics.

Drawings must be original, correct in safety concept and the exclusive work of the student entering the contest in idea, design and execution. All artwork should be positive in approach, demonstrating only proper school bus safety behaviors. At least a part of a yellow school bus must be present in the poster.

There must be a 3" x 5" card/entry blank securely fastened to the back of the poster which includes the student's name, grade, age, teacher's name, email address, school name and school address. Please print clearly. Do not place name, school, etc., on the front of the poster. Display information on the back only.

An art instructor or art teacher should supervise all work.






